The Summons is (except for the date and time for appearance) identical to the Summons dated 27.10.2010, in the name of our client, that was similarly delivered at the office of Godfrey Philips India Ltd., on 29/10/2010. A copy of this Summons is, for convenience, annexed as Annexure "1" (at page 1). We had responded thereto by our letter dated 3rd November 2010. A copy of this letter is, for convenience, annexed hereto as Annexure "2" (pages 2 to 5).
- 6. For the sake of brevity, we reiterate what has been stated in our letter dated 3rd November 2010. The same may kindly be treated as forming part of this letter.
- 7. As no cognizance appears to have been taken off what was stated in our letter dated 03/11/2010, we reiterate the following:-
 - Our client is not in a position to attend your office at 11.00 hours today, as required under your Summons;
 - b. Our client conveys his sincere apologies for the same;
 - c. The reason for our client's inability to attend before you, is because of the elevated threat perception of a serious threat to his life and safety and that of his family members and is unable to remain present as requested.
 - d. Our client, in this behalf, requests you to kindly consider the following:
 - i. On 14.10.2009, our client received an e-mail from an unknown source threatening him with dire consequences. The e-mail speaks for itself. A copy thereof was forwarded with our letter dated 3rd November 2010. The same is once again enclosed for your ready reference, as <u>Annexure "3"</u> (at page 6).
 - ii. Our client was informed, by the Mumbai Police that they had intercepted communications, which indicated the existence of a plan, by operatives of the underworld, for his assassination. Our client is not privy to the exact details of the intercepted communications and the steps taken in pursuance thereof, since this information is classified. The intelligence reports referred to are of the highest credibility and thus a legitimate apprehension of his safety.

- iii. The threat perception has however been the subject matter of a host of media reports, which have particularly commented on the existence of a threat to our client's life from the underworld. Copies of some of these media reports were forwarded with our letter dated 3rd November 2010. The same are once again enclosed, for your ready reference, as Annexure "4" (at pages 7 to 16).
- iv. During IPL Season 3 also there was a significant threat perception. As a result thereof, apart from the protection given by the local police authorities, our client was advised to employ private specialized close protection security. Accordingly, our client retained the services of NSA who are internationally recognized as specialists in close protection security to provide him additional protection. This was to the knowledge of local law enforcement agencies. It is for this reason that various states gave him additional high level security during IPL matches in the respective states. Our client, also submitted applications to the Government for importing enhanced security equipment (automatic weapons, armoured vehicles etc): at the time when he left India, these applications were still pending.
- v. As the IPL Season was over, there was a reduction in the level of protection by the local agencies. Our client however stayed back in India and co-operated with the Income Tax Department. After having responded to the Summons from the Income Tax Department and after finalizing his Reply to the BCCI Show Cause Notice dated 25th April, 2010, our client felt compelled to leave India on 13th May, 2010, on account of the continuing threat perception and serious concerns about his safety. It is significant to note that, at this stage, our client had not been summoned for any other investigation, by any other agency, including the Enforcement Directorate or yourselves.
- vi. Even after he left India, his son and wife were under threat. Our client therefore corresponded with the Mumbai Police. These letters form part of the documents forwarded to you under cover of our letter dated 3rd November 2010. This correspondence is once again enclosed for your convenience, as Annexure "5" (at pages 17 to 35). Our client's son was, as a result, provided continuous protection, even whilst in school.

- vii. In our letter dated 03/11/2010, we had drawn your particular attention to a report in the Mumbai Edition of the Times of India dated 18.07.2010, which reported that the Mumbai Police had confirmed the existence of a life threatening risk from the underworld. We once again request you to consider this.
- viii. In our letter dated 03/11/2010, we had also drawn your attention to media reports, as recent as 29th October, 2010 (on NDTV) which recorded that the Mumbai Police had confirmed the existence of the threat. The NDTV article is available on-line at the web site of NDTV (see: http://www.ndtv.com/article/india/mumbai-police-endorse-lalit-modis-life-threat-claim-63329).
- 8. We reiterate that if despite what is stated above, should you still require further corroboration, you may kindly verify the same from the Joint Commissioner of Police (Crime Branch) Mumbai.
- 9. In view thereof, our client cannot personally present himself in your office, as required.
- 10. Our client requests that this may not be construed as not co-operating with or assisting, the Directorate of Revenue Intelligence. Our client is willing to appear before you through video conferencing or in person, in London. His inability to physically present himself before you, in Mumbai, as requested, may kindly not be regarded as "willful" or a non compliance of your Summons. This inability is on account of genuine and bona-fide reasons, which have been set out above.
- 11. Our client wishes to emphasize that he is willing to offer all necessary co-operation in the matter. In particular:-
 - a. our client shall answer, orally or in writing, any questions or requisitions that the DRI, may wish to put to him;
 - b. our client shall answer questions through a video link;
 - c. our client shall appear before the DRI officials, in London, at a place of their convenience. They can question him for as long as they desire;

- d. our client shall, if required, make all arrangements for the travel and/or stay of DRI officials to London.
- 12. We trust that this establishes that our client is willing to fully co-operate with the authorities concerned. Our client is residing in London, which is a well known fact. His address and contact telephone numbers have already been supplied to the Department.
- 13. In the meanwhile, our client wishes to state that the various allegations of violations of law are false and motivated. The allegations that he has acquired foreign exchange outside India worth crores of rupees are completely false and motivated. Even the BCCI has not made any such allegations against him.
- 14. Our client respectfully urges that he is apprehensive as to whether the issuance of this summons, within a few hours of the receipt of our letter dated 3rd November 2010, without taking into consideration what has been stated therein, is an attempt to act on your threat, in the Summons, that his non attendance will constitute an offence under Section 174 of the Indian Penal Code.
- 15. Our client sincerely hopes that your actions are not motivated. If that be the case, you will kindly examine the contents of this letter and our letter dated 3rd November 2010 and verify the information from the concerned authorities and thereafter, in the interest of investigation, accede to the requests contained therein.
- 16. Our client is a well respected and law abiding businessman of repute. We hope that you will not precipitate matters.


Indian intelligence agencies have warned that Lalit Modi, IPL chairman is among the latest to be on the hit list of the underworld. It has been alleged that Modi is being targeted because Pakistani cricket players have not been allowed to participate in the IPL this year. According to cricket news reports, a Pak based organisation had given a so called 'supari' to underworld don Chota Shakeel to 'eliminate' Modi either in India or South Africa. According to reports, this information was gleaned from the interrogation of shooter Rashid Malabari who is also connected with international cricket according to whom Modi is one of the prime targets of the gang of Chota Shakeel. Malabari is a gangster who is associated with the Chota Shakeel gang, and was arrested last week. It has been revealed that the main aim of the plot to assassinate Modi was to create panic and chaos ahead of the Indian elections.

And Modi is not the only one targeted by this gang; others such as Varun Gandhim (BJP candidate from Pilibhit) Pramod Muthalik (of the Ram Sene attacks on the Mangalore pub fame). Reportedly these are the other people on the Chhota Shakeel radar.

Modi reportedly became an underworld target after he failed to cough up the money demanded of him by the gang. In the event there is no perceived threat to the cricket players participating in IPL Season 2 for who the highest security measures will any way be in place. It is also the betting mafia which is involved in international cricket and which is highly active in the South African region according to cricket news reports.

There is also nexus between Islamic fundamental militant organisations and the underworld gangs which further ups the risk faced by Modi. Although agencies have indicated and cricketers are safe and not the target of militants, sabotage of matches is not inconceivable possibility which must be kept in mind.

Mumbai cops confirm threat to Lalit Modi

MUMBAI: The Mumbai Police has confirmed that controversial Indian Premier League (IPL) chief Lalit Modi has indeed received a threat from underworld don Dawood Ibrahim's principal aide Chhota Shakeel. Modi stayed away from BCCI's disciplinary committee's meeting on Friday, with his lawyer citing the threat.

The threat, it is learnt, had to do with betting on matches in the third edition of IPL TOI, in its edition dated April 28, 2010, had reported about the alleged involvement of D-Company in the betting on IPL matches through top Pakistani bookie Numan Miya and his Indian counterparts Rakesh and Rajesh of Jaipur.

The Jaipur bookies, who have since gone underground, are known for their proximity to certain major players of the Indian cricket business, sources said

The threat from Shakeel, who is based in Karachi, was essentially aimed at silencing Modi who knows too much about the "inside story of IPL matches", said sources.

Incidentally, Shakeel had similarly threatened and silenced Jagdish Joshi, owner of 'Goa gutkha', who had intimate knowledge of the involvement of certain Indian politicians in gutkha smuggling and manufacture in Pakistan.

Joshi had told TOI how he received a call from Shakeel asking him not to give any information to CBI which was probing the multi-crore gutkha scam in which Dawood's brother Ances Ibrahim and nephew Abdul Hamid Antulay were involved.

Modi is likely to be provided with a foolproof security cover, especially when he comes to Mumbai.



I am writing this letter to you in concern of my Son & Wife's protection with regards to the new turn of events. From the 26th of April 2010 Alvin Porter from NSA South Africa has been working with my son Ruchir. Since he has started to work with Ruchir there has been a few events that have taken place and he has just addressed these events to me this morning. Turn of events reported to me by Alvin this morning follow –

- 1. The protection office on the 11th of May 2010 called Subeesh Soman who is Ruchir's other Personal Security Officer and had mentioned that effective 11th May 2010 Ruchir will not be getting 24hrs protection and he will only receive protection from 8am to 8pm.
- 2. Morning of 20th of May 2010 Ruchir's protection constable Sugrrive Kamble who had been reporting to the 8am to 8pm duty since the beginning of the IPL tournament had been replaced by Rakesh Jagtap.
- 3. Morning of 21st of May 2010 No personal from the protection branch had reported to Ruchir's duty.
- 4. Morning of 21st of May 2010 we had received 3 letters delivered by Rajesh Wakkar (constable of Mumbai Police Protection Branch). I have attached all 3 letters.

- a. First & Second letter stated the payment due for my Police Protection, which will be, cleared ASAP from the DY. Commr. Of Police (protection) Bombay.
- b. The third letter dated 20th of May 2010 from the Sr. Inspector of Police (Protection) Bombay S.R.Ranchevre mentioned that Ruchir's protection will be canceled effective 21st May 2010.
- 5. 21" of May 2010 Ruchir was driving in a black BMW 740ILi which is usually my car and was escorted by a Honda Accord which is usually Ruchir's car. In the BMW Ruchir was seated along with the driver Roney D'Souza and Alvin Porter (Ruchir's Bodyguard), in the Honda Accord there were 3 people seated in the car, the driver Vijay Chowgule, Subeesh Soman (Ruchir's bodyguard) & Viswanath Jawlekar (Ruchir's 3rd bodyguard from Ace Security & Protection) on route from Cuffe Parade to our apartment building Westmore on Sir. Porchkanwala Road Worli, Mumbal, Alvin Porter noticed a Silver-Grey Mahindra Scorpio with his lights off which began to tail behind Ruchir's escort vehicle, Honda Accord for approx. 3km from half was point to the apartment in Worli. The second Alvin noticed the vehicle had tailed us to our street where the apartment building is located, Alvin then immediately instructed Ruchir's driver Roney D'Souza to drive past the apartment and continue straight along Sir. Porchkanwala Road while instructing Subeesh Soman who was in the escort vehicle, Honda Accord to stay back and stall the Mahindra Scorpio that was tailing us. Ruchir's driver then rerouted towards Worli Seaface rendezvous to the apartment. Subeesh then informed Alvin that the vehicle that was tailing us had noticed the Honda stalling him, then had speed off into a nearby ally way. Subeesh did not engage and had rerouted to the apartment and made sure that he was not being tailed by changing his route.
- 6. 22nd of May 2010 Ruchir had attended an American School of Bombay function where he attends school, the function took place at the Taj Lands End, Bandra, Mumbai. Ruchir then departed to Cuffe Parade then

to Privé a lounge in Colaba to meet with friends. Ruchir had booked a table at Privé in his name; Subeesh noticed then informed Alvin that there was a group of 4-5 men standing nearby his table the whole time Ruchir was there. A member of the same group of 4-5 men standing nearby his table had taken a photo of Ruchir, Alvin and Subeesh then walked off into the crowed. The rest of the group remained nearby Ruchir's table, where one of the men in the group (a bald man in a green t-shirt) began pointing at Ruchir this was noticed by Subeesh and Alvin. Then Alvin approached a random patron in the crowed and asked he knew about the group standing by the table, the patron quoted to Alvin that "Those guys are gangsters, they are Indian mafia you do not want to mess with them". Alvin then immediately informed Subesh and evacuated Ruchir with help form 3 of the Privé Security through the rear service area. Ruchir was then seated in a Black BMW 750LI, which I used to use for the past 2 years. Immediately from Privé Ruchir departed to the apartment in Worli escorted by his security team Alvin, Subeesh, and Viswanath.

I urgently request you to assist me in this matter and provide Ruchir and my wife Minal Modi with a high level of police protection 24 hours. I am willing to bear costs for the protection that you provide my family.
